**Management's Discussion and Analysis**

**For the nine months period ended June 30, 2017**

The following Management Discussion and Analysis (“MD&A”), prepared by the management of EnGold Mines Ltd. (Formerly GWR Resources Inc.). (the “Company”, “EnGold”) as at June 30, 2017, should be read in conjunction with the Company’s condensed interim financial statements for the period ended June 30, 2017 and the annual audited financial statements for the year ended September 30, 2016 and related notes attached thereto which are prepared in accordance with International Financial Reporting Standards. Certain statements included or incorporated by reference in this MD&A constitute forward-looking statements or forward-looking information under applicable securities legislation. These forward-looking statements are not guarantees of future performance and involve risk and uncertainties, which could cause actual results to differ materially from those anticipated. The Company expressly disclaims any obligation to update forward-looking statements unless so required by applicable laws.

## **1. Nature of Operations and Overall Performance**

### **Description of Business**

EnGold Mines Ltd. (formerly GWR Resources Inc.) is incorporated under the Business Corporations Act (British Columbia) and is listed on the TSX Venture Exchange under the trading symbol "EGM". The Company changed its name pursuant to a shareholders' resolution passed at the Company's Annual General Meeting held April 22, 2016. Management recommended the change to better reflect the Company's increasing focus on gold exploration.

The Company is a mineral exploration company whose principle focus is the exploration and development of Lac La Hache property located approximately 17 kilometres north northeast of Lac La Hache in south central BC (the “Property”). The Property is accessed by approximately 30 kilometres of all-weather logging roads. Lac La Hache is located on BC Highway 97 approximately 65 Kilometres south of Williams Lake, and is well served by rail, road and power infrastructure. Operations on the Property may be carried out 12 months of the year. The Company has accumulated the Property and conducted exploration since 1988.

### **Exploration Program and Results**

#### **Lac La Hache Property**

During the nine-month period ended June 30, 2017, expenditures of \$1,965,189 were incurred on the Lac La Hache property for drilling and other exploration costs, which activity was a continuation of the \$352,208 exploration expenditures that were incurred on Lac La Hache during the 12-month period ending September 30, 2016, which

expenditures were part of a 3,850 metres drill program at the property that was completed during the period. The results of the program were encouraging.

The Lac La Hache (LLH) Property lies within the Quesnel Trough in British Columbia, Canada's largest and most prolific porphyry copper-gold-molybdenum belt. The property hosts gold, copper, silver and magnetite within porphyry/skarn/breccia geological settings located between producing mines at Imperial Metals' Mt. Polley Copper-Gold Mine and New Gold Inc.'s New Afton Copper-Gold project. Access and infrastructure are excellent.

Management believes the LLH Project offers strong potential for development and discovery. The extensive core library has been well documented in a robust digital database.

During the year ended September 30, 2015, management decided that the most compelling prospect on the Property was the Aurizon South zone, which previously had yielded significant high-grade gold copper values over potentially minable widths. During the fourth quarter of fiscal 2015, EnGold Mines Ltd completed a \$400,000 flow-through equity financing and commenced a 2,600 metres diamond drilling program targeting the Aurizon South. Results of the program, carried out in two phases, one of which was completed subsequent to year end, confirmed and expanded the known high-grade gold/copper zones.

During the three-month period ended December 31, 2016, EnGold completed 12 drill holes comprising 3,851.5 metres with continued high-grade gold and copper results. 11 holes of which targeted the Aurizon South. The continued encouraging results enabled the company to raise an additional \$1,100,000 in flow-through funding in December 2016, which is earmarked for further Aurizon South drilling expected to commence in Q1 2017.

In addition to successful drill results at Aurizon South, in 2015 EnGold identified a new zone of porphyry copper mineralization named the Berkey Zone. The Berkey Zone exhibits copper grades in host rocks geologically similar to large orebodies in the region. The Company is actively seeking a joint venture partner to help explore the Berkey Zone, as management sees this path as the most efficient means of quickly and effectively exploring the new area.

### **New Discovery**

EnGold's first drill hole of 2017 targeted a geophysical anomaly in an area of the LLH property with no prior drilling. The drilling encountered 1.76% copper, 0.27 grams per ton gold, 10.29 g/t silver and 35.8% iron over 26.57 meters in a previously undrilled area of its' 100% owned Lac La Hache Property in the Cariboo region of BC. Within this, a 14-m thick interval exceeds 2% copper. The skarn-type mineralization is located 1.8 km southeast of the existing copper-gold-silver-magnetite resource defined at the Spout Deposit.

Additional drilling tested the discovery area in fifty-meter step outs that provided sufficient encouragement to warrant further drilling that is ongoing at time of writing. Also, follow-up geophysical surveys identified additional anomalous zones along a projected 5.5 kilometres zone that the Company believes warrants significant additional exploration.

In April 2017, the Company completed an additional \$2 million flow-through private placement which has been earmarked for further exploration of the discovery area.

During the six months ended June 30, 2017, EnGold completed 21 drill holes in the discovery area and two additional holes targeting on-trend anomalies for a total of 10,182.8 metres of drilling. Ninety per cent of the holes drilled to date have encountered skarn-style mineralization across widths ranging from two to 43 metres in true thickness. Although there may be a northeast/southwest trend emerging, the geometry of the mineralization has yet to be determined, and less than 50 per cent of the mag/gravity geophysical anomaly has been drilled to date. With data from the newly completed airborne survey now being processed, modelled and interpreted, together with the significant additional ground gravity data collected over several weeks, Engold's technical team is developing the next series of drill targets, both at the discovery area and at anomalies along the 5.5-kilometre anomalous trend.

Results from the program included hole G17-16, which intersected 43.45 metres grading 1.31 per cent copper, 0.2 gram per tonne (g/t) gold, 4.06 g/t silver and 31.14 per cent iron, including 24 metres grading 1.67 per cent copper, 0.29 g/t gold, 5.09 g/t silver and 34.55 per cent iron. Hole G17-16 is collared 142 metres northeast of discovery hole G16-01, which intersected 26.57 metres grading 1.76 per cent copper, 0.27 g/t gold, 10.29 g/t silver and 35.8 per cent iron. Holes drilled as stepouts from G17-16 intersected discontinuous, narrow mineralized intervals. Hole G17-23 intersected the subhorizontal main mineralized zone approximately 71 metres southwest of G17-04, appearing as several semi-massive magnetite-chalcopyrite intervals totaling 14.35 metres over a wider 19-metre interval.

Subsequent to the end of the period, on July 10<sup>th</sup>, 2017, EnGold announced that due to extreme levels of forest fire activity in the Cariboo region, the Company temporarily stopped its exploration program. While no fires have been reported on the LLH Property itself, heavy smoke, closed roads and intermittent power outages have made continued operations unsafe and unworkable. The town of Lac La Hache, where the company's exploration office and workshop is located, is currently on evacuation alert.

### **Resource Property Interests – Exploration and evaluation expenditures**

The strong exploration results obtained in 2016 at the Lac La Hache Property have renewed management's commitment to aggressively exploring and developing the Property. Management was able to raise sufficient funds in the near term for an expanded drill program at Aurizon South that is providing additional data to that will assist the Company in completing a resource calculation that can be disclosed in accordance with NI 43-101.

## **2. Results of Operations**

During the nine months period ended June 30, 2017, 2016, the Company had a loss of \$2,212,934 (2016 – \$321,798). Significant activities during the period were as follows:

- **Depreciation** – decrease to \$4,847 (2016 - \$11,313) as the Company is amortizing assets over the course of the fiscal year.
- **Exploration and evaluation expenditures** – increased to \$1,965,189 (2016 – \$174,615) as the Company continue to aggressively work on its exploration project with funds raised during the period.
- **Filing and regulatory** – increased to \$47,574 (2016 - \$14,018) as the Company was active raising funds during the period.
- **Office and other** – increased to \$106,333 (2016 - \$30,377) as the Company incurred additional head office costs as a result of the exploration projects and funding received.
- **Management and consulting fees** – decreased to \$73,406 (2016 - \$86,815) which is comparable to prior period.
- **Share-based payments** – increased to \$263,037 (2016 - \$Nil) as a result of stock options granted and vested during the period.

### 4. Liquidity

The Company's historical capital needs have been met by issuance of shares. As at June 30, 2017, the Company's working capital was \$1,423,114 (September 30, 2016 – \$164,950). The Company proposes to meet any additional financing requirements through equity financing.

The Company's cash position as at June 30, 2017 was \$1,646,417 (September 30, 2016 - \$114,826). The increase in cash is due to three private placements that occurred in the period ended June 30, 2017 in addition to option and warrant exercises.

The Company does not have operations that generate cash flow and it is unlikely that it will generate cash flow from operations in the foreseeable future.

Cash requirements will depend primarily on the extent of future exploration programs. Subsequent phases will depend, both on cost and duration, and on results from previous phases, and it is therefore extremely difficult to predict future cash requirements. As of the date of this filing, the Company does not have the adequate funds on hand to complete its planned exploration program for the fiscal year 2017.

The Company is dependent on raising funds by the issuance of shares in order to undertake exploration and development interests and meet general and administrative expenses beyond one year in the future. There can be no assurance that the Company will be successful in obtaining their required financing.

## **5. Capital Resources**

The Company's ability to raise additional funds from the equity markets will largely depend upon general market conditions and the Company's ability to achieve certain exploration milestones.

Issued and outstanding common shares at July 17, 2017, the date of this report is 187,909,542 (June 30, 2017 – 188,109,542).

## **6. Related Party Transactions**

Key management personnel comprise the Chief Executive Officer, Corporate Secretary, Vice President of Exploration and Directors of the Company. The remuneration of the key management personnel for the period ended June 30, 2017 is as follows:

- Included in management and consulting fees was \$35,000 (2016 - \$50,000) for services provided by the CEO and \$15,800 (2016 - \$10,000) paid to the corporate secretary.
- Included in exploration and evaluation expenditures are \$166,000 (2016 - \$46,800) for geological consulting services to a company controlled by the Vice President of Exploration.

An amount of \$Nil (September 30, 2016 - \$18,992) included in accounts payable to the CEO. All balances are unsecured, non-interest bearing, have no fixed repayment terms, and are due on demand.

#### **7. Off-Balance Sheet Arrangements**

There is no off-balance sheet arrangement to which the Company is committed.

#### **8. Subsequent Events**

Subsequent to the period ended June 30, 2017:

- a) 533,334 warrants with exercise price \$0.10 were exercised for gross proceeds of \$53,333.

#### **9. Proposed Transactions**

The Company has no specific proposed transactions. However, consistent with the nature of the Company's operations, the Company is continuously reviewing potential mineral property acquisitions and is likely to acquire additional mineral properties in the future.

#### **10. Legal Proceedings**

During the year, the Company was a party to a number of legal proceedings.

- *Birch v EnGold*. In 2012, a suit in the Supreme Court of BC was brought by a former investor relations employee seeking a finder's fee on a private placement completed in 2011. EnGold believes the suit was completely without merit, there was no fee due and vigorously defended the case, for which a summary trial was held in June 2015. Notwithstanding, on January 27, 2016, EnGold received Reasons for Judgement from the court awarding Birch \$55,000 plus costs. EnGold disputed the judgment and filed an appeal on January 28<sup>th</sup>, 2016. On April 5, 2017, EnGold's appeal was heard before the Court of Appeal. On May 16, 2017, the Court ruled in favour of Birch by dismissing EnGold's appeal. Subsequent to the end of the period EnGold paid \$71,952.31 in full and final settlement of the matter representing the award plus costs.
- *Glimhagen v EnGold*. In fiscal Q4 of 2015, a former accounting contractor who was also CFO and an employee for one year (ending September 2012) brought suit in the Supreme Court of BC against EnGold for wrongful dismissal. Management has been of the view that the suit was wholly without merit and has vigorously defended the case. Subsequent to the end of the period, a trial proceeded (April 19-21, & 24, 2017) and Reasons for Judgement were received May 10, 2017 awarding Mr. Glimhagen \$78,000. Subsequent to the end of the period, the Company paid \$98,304.42 in full and final settlement of the matter representing the award plus costs.
- *Eisler v EnGold*. In fiscal Q4 of 2015, a holding company 100% owned by a former CEO of the Company brought suit in the Supreme Court of BC against EnGold for wrongful dismissal arising out of the termination of Mr. Irvin Eisler's employment in 2011. Management believes that the Company's termination of Mr. Eisler for cause was entirely justified, and the present case is wholly without merit. The Company has filed a counterclaim against Eisler et al for unspecified damages relating to significant amounts of inappropriate related party payments that accrued to Mr. Eisler's benefit during his tenure. No contingent liability has been recorded on the Company's books for this case. A trial date has been set for October 2017.

#### **11. Critical Accounting Estimates and Judgements**

The preparation of these financial statements requires management to make certain estimates, judgments and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported expenses during the period. Actual results could differ from these estimates.

Significant assumptions about the future and other sources of estimation uncertainty that management has made at the end of the reporting period, that could result in a material adjustment to the carrying amounts of assets and liabilities in the event that actual results differ from assumptions made, relate to:

*Critical accounting estimates*

- i. The Company has not recognized a deferred tax asset as management believes it is not probable that taxable profit will be available against which deductible temporary differences can be utilized.
- ii. Share-based payments are subject to estimation of the value of the award at the date of grant using pricing models such as the Black-Scholes option valuation model. The option valuation model requires the input of highly subjective assumptions including the expected share price volatility. Because the Company's warrants have characteristics significantly different from those of traded options and because the subjective input assumptions can materially affect the calculated fair value, such value is subject to measurement uncertainty.

#### *Critical accounting judgments*

- i. The carrying value and recoverability of exploration and evaluation assets requires management to make certain estimates, judgments and assumptions about each project. Management considers the economics of the project, including the latest resources prices and the long-term forecasts, and the overall economic viability of the project. Management has assessed these indicators and does not believe an impairment provision is required.
- ii. Although the Company has taken steps to verify title to mineral properties in which it has an interest, these procedures do not guarantee the Company's title. Such properties may be subject to prior agreements or transfers and title may be affected by undetected defects.
- iii. The estimate for contingencies and settlement provisions require management to make judgments as to the likelihood of outcomes, and estimates of the timing and the possible outflow of economic benefits.

#### **Disclosure Control and Procedures**

##### **Internal Controls and Procedures**

The Chief Executive Office and Chief Financial Officer are responsible for designing internal controls over financial reporting in order to provide reasonable assurance regarding the reliability of financial reporting and the preparation of the Company's financial statements for external purposes accordance with IFRS.

Certain weaknesses exist in internal controls over financial reporting. As indicative of many small companies, the lack of segregation of duties and effective risk assessment were identified as areas which existed. The existence of these weaknesses is to be compensated by senior management monitoring, which exists. The officers will continue to monitor very closely all financial activities of the Company and increase the level of supervision in key areas. It is important to note that this issue will also require the Company to hire additional staff in order to provide greater segregation of duties. Since the increased costs of such hiring could threaten the Company's financial viability, management has chosen to disclose the potential risk in its filings and proceed with increased staffing only when the budgets and workload will enable the action.

##### **Risk Factors**

In conducting its business, the Company, like all development-stage mineral exploration companies, faces a variety of risks uncertainties. While unable to eliminate all of them, the Company aims at managing and reducing such risks as much as possible.

Exploration and Development - Resource exploration and development is a highly speculative business, characterized by a number of significant risks including, but not limited to, unprofitable efforts resulting not only from the failure to discover mineral deposits but also from finding mineral deposits that, though present, are insufficient in quantity and quality to return a profit from production. Few exploration projects successfully achieve development due to factors that cannot be predicted or anticipated, and even one such factor may result in the economic viability of a project being detrimentally impacted such that it is neither feasible nor practical to proceed. The Company closely monitors its activities and those factors that could impact them, and employs experienced consulting to assist in its risk management and to make timely adequate decisions.

Title Risks - Title to mineral properties involves certain inherent risks due to the difficulties of determining the validity of certain claims, as well as the potential for problems arising from the frequently ambiguous conveyance history characteristic of many mineral properties.

Permitting Risks - The development of mineral resources in British Columbia is subject to a comprehensive review, approval and permitting process involving various provincial and regional agencies, in addition to the various First Nations groups that have jurisdiction in the Company's area of claims. There can be no assurance given for the



required approvals and permits for a mining project, even if technically and economically warranted, can be obtained in a timely or cost effective manner.

Fluctuating Metal Prices - Factors beyond the control of the Company have a direct effect on global metal prices, which have fluctuated widely, particularly in recent years. Consequently, the economic viability of any of the Company's exploration projects and the Company's ability to finance the development of its projects cannot be accurately predicted and may be adversely affected by fluctuations in metal prices.

Environmental Regulations, Permits and Licenses - Environmental laws and regulation could also impact the viability of a project. The Company has ensured that it has complied with these regulations, but there can be changes in legislation outside the Company's control that could also add a risk factor to a project.

Competition - The mineral exploration industry is intensely competitive in all its phases, and the Company competes with some companies that have greater financial and technical resources. Competition could adversely affect the Company's ability to acquire suitable properties or prospects in the future.

Future Financings - The Company's continued operation will be dependent in part upon its ability procure additional financing. To date, the Company has done so through a combination of: (i) equity financing; and (ii) cash payments received as property option payments from third parties. The current state of global equity markets has had a direct effect on the ability of exploration companies, including the Company, to finance project acquisition and development through the equity markets. There can be no assurance that forms of financing can be obtained at a future date. Failure to obtain additional financing on a timely basis may cause the Company to postpone development plans, forfeit rights in some or all of the properties or joint ventures, or reduce or terminate some or all of the operations.

Price Volatility of Publicly Traded Securities - During recent months, global securities markets have experienced a high level of price and volume volatility, and the market prices of securities of many companies have experienced wide fluctuations in price that have not necessarily been related to the operating performance, underlying asset values or prospects of such companies. There can be no assurance that continual fluctuations in price will not occur.

## **12. Approvals**
